

**ADVERTISEMENT FOR BIDS**

Adams County / Ohio Valley School District, 141 Lloyd Road, West Union, Ohio 45693, will accept sealed BIDS for "Peebles High School Renovations" located at 144 Peebles-Indian Drive, Peebles, Ohio 45660. These BIDS will be received at the office of Adams County / Ohio Valley School District, Attn: Brian Switzer, Treasurer, 141 Lloyd Road, West Union, Ohio 45693, until 10:30 a.m. local time, May 17, 2017. The bids will be opened and read aloud at the Adams County / Ohio Valley School District at 10:30 a.m. of the same day.

The WORK entails renovations to Peebles High School to create a secure entry.

Separate bids will be received for the following bid packages ("work") as described in the Contract Documents:

1. General Trades
2. Electrical
3. HVA/C – Mechanical

Subject to the right of the OWNER to reject any and all bids and as provided below. The OWNER will award a single contract for each division of work listed above or one or more combined contracts for combination(s) of the foregoing divisions of work. Bidders must furnish all information requested on or accompanying the bid proposal. Failure to do so may result in disqualification of the bid.

Each BID must be submitted in a sealed envelope plainly marked on the outside as " PEBBLES HIGH SCHOOL RENOVATIONS, 144 PEBBLES-INDIAN DRIVE, PEBBLES, OHIO 45660."

Copies of the Contract Documents consisting of the plans and specifications and items of work, the proposal and contract forms may be obtained at the office of the ARCHITECT/ENGINEER, McCarty Associates, LLC, 213 North High Street, Hillsboro, Ohio 45133, Phone: (937) 393-9971, Fax: (937) 393-2480. Documents may be obtained electronically or in paper format. To obtain documents electronically, interested parties must be placed on the Plan Holder's List by completing a Plan Holder's List Application as provided by the Architect. For paper copies of the bidding documents, interested parties must complete the Plan Holder's List Application and pay a nonrefundable charge of \$100.00 plus \$20.00 shipping & handling for each set so requested.

Each proposal shall be signed by the full name and business address of each person or company interested in bidding, and shall be accompanied by a surety bond by a bonding company authorized to do business in the State of Ohio, or by a certified check, cashier's check or letter of credit from a solvent bank, all in accordance with ORC 153.571. The bid guaranty bond shall be for the full amount of the bid and the certified check, cashier's check, or letter of credit shall be equal to a minimum of ten percent (10%) of the submitted proposal and made payable to Adams County / Ohio Valley School District. Proposals accompanied by certified check, cashier's check, or letter of credit will require a subsequent contract performance bond in the amount of one hundred percent (100%) of the contract amount. All provisions of the Ohio Revised Code, as it relates to bid guarantees, conditions, liabilities, and withdrawal of a bid are pertinent to this contract.

The proposal must be made on the forms provided therefore in the contract documents, or a copy thereof, with a price quoted for the work.

The OWNER reserves the right to waive any informalities and to reject any or all bids.
